Entry Requirements:

- To qualify, Cardholders are required to make a spend of J\$15,000/US\$100 or more on any NCB Visa consumer credit cards, including NCB Visa Classic, Visa Platinum, Visa Signature, and Visa Signature Cash Back cards ("Cardholders"). Method of Winner Selection:

Method of Notification:

- Potential winners will be contacted within five (5) business days of each draw date. Selected winners will be contacted via telephone.
